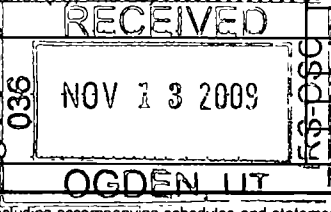

The program supports both established policy thinkers, and those who have exceptional potential but are not yet well established. All come to New America to pursue solutions-oriented research and writing projects of their own design.

The Fellows Programs wrote 478 articles and policy papers, held 18 public policy events and had 333 media appearances.
