**THE UNITED STATES' SUPPLEMENTAL RESPONSE
TO THE COURT'S NOVEMBER 5, 2014 ORDER**

On November 5, 2014, the Court issued an order lifting the suspension of its review of redactions proposed by the Government to documents filed in the above-captioned matter. The order further directed the Government to propose, inter alia, a timetable for submitting the following materials to the Court:

- (a) a statement enumerating the Government's position on whether a previous redaction proposal, submitted September 12, 2013, should be modified given the subsequent review of the relevant materials by the Foreign Intelligence Surveillance Court of Review ("FISCR"), along with a modified redaction proposal if appropriate; and
- (b) a statement enumerating the Government's position on whether a separate redaction proposal, submitted September 27, 2013, should be modified given the subsequent review of the relevant materials by the FISCR, along with a modified redaction proposal if appropriate.

On November 18, 2014, the Government submitted a response to the Court's November 5, 2014 Order; indicating, inter alia, that it would submit responses to the questions described above (along with modified redaction proposals, if appropriate) to the Court by December 12, 2014. The Government hereby responds as follows:

On July 29, 2013, the Government, in a submission to this Court, indicated that it would undertake a classification review of the Memorandum Opinion, legal briefs, and certain other materials submitted by the parties in the above-captioned matter. An Appendix accompanying the Government's July 29, 2013 submission ("Appendix A") listed the specific documents the Government proposed to review.

A substantial number of the documents listed in Appendix A were also made part of the record in the appeal of this matter to the FISCR. Those documents were subject to a parallel classification review ordered by the FISCR. On October 22, 2013, this Court indicated that it had suspended its own review of the documents in Appendix A "in order to permit the results of the declassification process before the [FISCR] . . . to inform its examination of declassified materials on the same subject matter." Order issued October 22, 2013. On September 11, 2014, the parties completed the classification review ordered by the FISCR, and the FISCR unsealed the redacted, declassified documents from the appellate record for public release.¹

The Government's position is that the documents listed in Appendix A subject to the recent classification review in the FISCR should not have to be re-reviewed by the Government as part of the parallel classification review ordered by this Court. The Government has created (1) an Annotated Appendix A (attached hereto as Exhibit 1) denoting the documents in Appendix A that were reviewed and released by the Government at the direction of the FISCR; and (2) a Revised Appendix A (attached hereto as Exhibit 2) listing the documents from the original Appendix A that were not reviewed by the Government as part of the classification review in the

FISCR. The Government proposes that the classification review in this Court be restricted to the documents listed in the Revised Appendix A.

(a) The Government's September 12, 2013 Redaction Proposal ("Group A")

Exhibit 1 reflects that the two documents implicated by the Government's September 12, 2013 redaction proposal were recently redacted, declassified, and released to the public in connection with the classification review in the FISCR. The Government does not believe it is necessary to conduct a second classification review of these documents as part of the review requested by this Court.

(b) The Government's September 27, 2013 Redaction Proposal ("Group B")

On September 27, 2013, the Government provided the Court with proposed redactions to most of the documents identified in "Group B" of Appendix A as briefs or other materials cited in the Court's Memorandum Opinion. As set forth in Exhibit 1, eight of the fourteen documents in Group B were recently redacted, declassified, and released to the public in connection with the classification review in the FISCR. The Government does not believe it is necessary to conduct a second classification review of these documents as part of the review requested by this Court. For those documents in Group B that were not subject to the classification review in the FISCR (and are accordingly included in the Revised Appendix A), the Government submits that the proposed redactions filed with the Court on September 27, 2013, do not need to be updated or modified; accordingly, the Court can review these documents. The Government will provide the Court with additional copies of these six documents on or before January 30, 2015, as part of its production encompassing documents in Group C of Revised Appendix A (discussed below).

(c) Relevant Briefs and Materials not Cited in the Memorandum Opinion
("Group C")

Exhibit 1 reflects that ten of the forty-three documents listed in "Group C" of Appendix A were recently redacted, declassified, and released to the public in connection with the classification review in the FISCR. The Government does not believe it is necessary to conduct a second classification review of these documents as part of the review requested by this Court. For those documents in Group C that were not subject to the FISCR classification review (and are accordingly included in the Revised Appendix A), the Government has proposed a deadline of January 30, 2015 to provide the Court with its proposed redactions to these documents.
