SUBJECT: STEFANOVICH, Radmila

1. Reference you letter of 1 August 1946, Subject above, this Officer contacted informant for further information concerning Pps 1 & 2 of your letter.

2. Subject above (according to informant) has lived with a certain SOLUNAC, Drago, (ex-Lieutenant in the Royal Yugoslav Army) in Rome and for a while in Trieste. SOLUNAC confided to our informant that he would marry Subject as soon as Subject finished some important work she was doing and for which she was being well paid. Subject further stated to SOLUNAC that the nature of her work prevented her from continuing her relations with him at this time and that only after her obligations were fulfilled would she consent to marriage. SOLUNAC also inferred that Subject's employers were the Yugoslav (Tito) Hqs. in Trieste. Informant also states that Subject is known as pro-Tito in Royal Yugoslav circles.

3. POPOVIC, Desa, lives with Subject. Her brother-in-law (nn) was a member of the German Gestapo in Lubliana, but after the liberation became one of the leading Communists in Lubliana. According to informant, POPOVIC's brother-in-law was a double Agent for Tito (having penetrated the German Gestapo) otherwise he would not be holding his present position in the Communist Party. POPOVIC is also marked as pro-Tito in Royal Yugoslav circles in Trieste.

4. LUIBO, Ciciliani is known to many white Yugoslavs as a guide and line crosser. In Nov. 1945 he is alleged to have aided the crossing of one man and two women from Jugoslavia into Italy. The man is only identified as VILKO and was a Yugoslav representing the Argentine Government at Zagreb. VILKO stated to our informant that LUIBO crossed the frontier after presenting OZNA identification papers to Yugoslav frontier guards. One Giovanni VITURI, San Nicolo # 15, Trieste, also told our informant that LUIBO by using his OZNA credentials effected the illegal crossing of his wife and child. Informant also stated that LUIBO has a very bad reputation in white Yugoslav circles and is feared by all as an OZNA gangster.

5. No other information is forthcoming from informant at this
