Pursuant to instructions from Supervising Agent, Zone 3, Milan Det., these Agents interrogated Subject and determined the following:

## MILITARY HISTORY .-

Subject was called for military service in July 1941 and was assigned to the 140th F.A. Regt. on the Russian Front, with the South Army. He was wounded on 15 Sept. 1943 and was evacuated to Germany. From Sept. to Dec. 1943 Subject was hospitalized at Frankfurt am Oder. In Dec. 43, Subject deserted and went to Hamburg on the Saar. In March 1943 he was apprehended by Military Police and sentenced to prison. In Sept. 1944 was released and sent to the 299th POW Receiving Rn. at Karlsruhe. On 27 Oct. 1944 was taken prismer by the Americans at St. Die' in France. Was hospitalized at the POW Hospital at Aix en Provence (44th General Hospital).

Subject was then sent to lager 404 near Marseille. On the night of the 24 Dec. 1945, he escaped and made his way to the Italian Frontier and crossed on foot into Italy at San Luigi near Ventimiglia. Discovered by Italian guard who mistock him for an American soldier and allowed him to continue. Subject, who had picked up english, made his way to Genoa posing as Jack MORRISON, American Soldier. Subject arrested near Verona on 7 January 1946 by CCRR and taken to San Vittore Prison

in Milan. On 15 June 1946, Subject was placed at the disposition of this Office.

## AGENTS' COMMENTS .-
